# Patron and Meeting Room Policies

Our scheduled policies to review are the patron and meeting room policies. These policies have been attached to the agenda. Changes to the meeting room policy will be discussed in New Business.

# Health Insurance

I have attached the plan proposal, which includes a summary on why this package is being presented, and a cost breakdown for the insurance options. Insurance rates have risen across the board for companies going into 2019. There is an explanation at the beginning of the proposal for the choices that are presented. A benefit of insurance plans since ACA is that we will be refunded anything we pay in our premiums that isn't for health needs because of lower claims. So, the healthier our staff are, the larger the reimbursement. This reimbursement has a 6-month lag. So, we won't know the exact reimbursement amount for 2018 until June/July of 2019. Right now it is only around \$1,969 because a staff member had a major surgery this year. This reimbursement in the past was then used to lower the amount staff pay at the end of the year.

A downside of our best option is that we would be expecting our staff pay \$180.76 a month for insurance and vision. I have also attached a breakdown from Danielle on what the cost of insurance has been in the past and a comparison on the library's yearly cost if we increased what the library pays so staff are only expected to pay \$100 a month.

# **Meeting Room Policy**

Attached are the two policy options for the meeting room policy. While talking with staff these past weeks, many have expressed great concerns about having two staff members stay after for time and a half while the meeting rooms are in use on Saturday. A lot of staff expressed they wouldn't feel right being paid extra to sit and watch the meeting rooms during a time that the library wasn't busy enough to be open. Also, since we are not open, we would still need to have the outside doors locked and police who should and shouldn't be coming in for a meeting room event. They are afraid how it would appear to younger meeting room guests that even though they are in the building and their librarians are at the front desk, they are not allowed to take their friends back to the children's department and enjoy the library. The staff members that deal mostly with the meeting rooms are concerned that we would still have people try to use the library or be extremely needy asking us for things that would take us away from the desk and therefore no longer watching the meeting room doors. Then the biggest concern was the scheduling. Most likely we would ask our staff that are scheduled for the Saturday if they would be willing to stay after. The problem with this is we schedule the meeting rooms 6 months out and we do not know our Saturday schedules 6 months out. Then if someone has agreed to do both shifts of the Saturday and they now need to switch they would need to find someone willing to switch and cover both shifts or find two people to cover their Saturday shift one during the normal hours and the other for the after-hours. Of all the staff I talked to, I only had a few say that they would be okay with staying after with a meeting. Those two staff members do not currently work the front desk or deal with the events in our meeting rooms.

We are also presenting the change in scheduling time and pricing structure for the meeting rooms. Currently, you can only rent the rooms for 4 hour increments. We are proposing renting the rooms for 2 hour increments. This would allow a group to have the room for 2, 4, 6 or 8 hours. We have quite a few meetings that don't use the rooms for their full 4 or 8 hours and would be grateful for this option. Also, this would allow a 2-hour program/event in the morning and afternoon on a Saturday. The proposed pricing schedule is attached to the agenda.

## Hot Spots

Hot spot lending is something libraries in rural areas are starting to offer their patrons. The hotspots can be checked out by patrons for a period of time. Jason looked into three different options of hot spots for a class project. The hot spots that were tested were on the Sprint and T-Mobile networks. Verizon and AT&T refused to let us trial their hot spots. The pricing for T-Mobile and Sprint is similar. The pricing for TechSoup's Mobile Beacon is about half the price, but it requires a contract and is grant based, so there is no guarantee that the pricing would stay the same. Sprint did not perform as well as the T-Mobile service outside of Bluffton in our rural areas. TechSoup's Mobile Beacon unfortunately uses Sprint for their carrier. Also, all of the other carriers other than T-Mobile throttle their data throughout the month. So, if a patron were to checkout a hotspot and use most of the data at the beginning of the month, the next patron to check-out the hotspot would have diminished data speeds.
