## Wells County Public Library Library Board of Trustees Meeting

- 1. Call to Order: The meeting was called to order by Vice President Tabor.
- 2. Opening of Sealed Bids: Bids were opened for the restroom renovation project. Bids were received from Corporate Construction for \$74,900, Fetters Construction for \$72,500 and Mosaic Building Solutions for \$70,600. A motion was made by Ryan to accept the Mosaic bid of \$70,600 subject to architect Steve Park's review of alternates for flooring. Acord seconded the motion which passed.
- 3. Public Input: None
- 4. Consent Agenda: Chaney moved to accept the consent agenda. Acord seconded the motion, which passed. The following items were approved and adopted:

- 5. 12-1 to 12-10, 2015 Register of Claims: Chaney moved to accept the register of claims, which totaled \$285,961.95. Ryan seconded the motion, which passed.

- 8. Committee Reports:
  - a. Building: The roof repair report from Mock was reviewed and discussed. Ryan made a motion to accept Option #3 for repair of the limestone tower for \$25,000. Acord seconded the motion which passed. Acord made a motion to hire Luther Mock and associates to oversee the project at his hourly rate not to exceed \$6,500. Chaney seconded the motion which passed.
  - b. Policy & By-Laws: The exhibit and display policy and information access policy were reviewed. There were no suggestions for changes.
  - c. Public Awareness/Outreach: Johnson reported that the staff Holiday treat has been delivered. Davis reported that the library has been involved with holiday displays at the Creative Arts, Historical Society, Oubache State Park and at the Ossian and Main Library.

- 10. New Business: A motion was made by Acord to approve Resolution 15-06 to reduce the Rainy Day Fund by \$175,000 and reduce the LIRF Fund by \$100,000. Ryan seconded the motion. Motion passed.

During a discussion of this presentation it was recommended that the board review the document <u>In Public Trust</u>. The board agreed to do this in 2016. Chaney asked Davis to check if the News-Banner is still printing a report of the most checked out books for the Wells County Public Library.
